## ELDERLY TAX EXEMPTION

The Town of Salisbury adopted the provisions of RSA 72:39-b for the Adjusted Elderly Exemption on March 13, 1991. At this year's Town Meeting, (March 8, 2022), the Town voted for the Elderly Exemption for the Town of Salisbury, based on the assessed value, for qualified taxpayers, as follows: for a person 65 years of age up to 74 years, \$50,000 (instead of \$40,000); for a person 75 years of age up to 79 years, \$75,000 (instead of \$60,000); for a person 80 years of age or older, \$100,000 (instead of \$80,000). To qualify, the person must have been a NH resident for at least 5 years, own the real estate individually or jointly, or if the real estate is owned by such person's spouse, they must have been married for at least 5 years. In addition, the taxpayer if single must have a net income of not more than \$40,000, or if married a combined income of less than \$45,000; and own net assets not in excess of \$75,000, excluding the value of the person's residence.

This modification shall be effective April 1, 2022. **NEW** applications for this exemption must be filed by April 15<sup>th</sup>. **Renewal** applications for this exemption must also be filed by April 15<sup>th</sup>.
